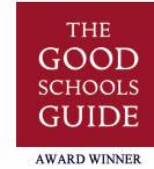

Ardingly Watersports is based on the reservoir at Ardingly. There will also be four activities, with students being able to have a go at sailing, kayaking, windsurfing, raft building and racing. You are invited to make a voluntary contribution of **£56.50** for the day at Ardingly.

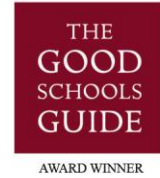
